2026 means a new year, new beginnings, and new members. We all hope that this new year brings us health and successful Legion endeavors.

Starting January 1st, the staff will be “carding” everyone, as you will be required to have your 2026 membership card to be served. If you have not renewed, do it today. Department will be sending renewal notices in January. **I do not send** out these renewal letters; I have been receiving “not so nice” letters telling me to check my records. I will explain one more time, the Legion dues year goes from June to June. If you pay your dues before January 1st you are entitled to Lounge privileges, that is a Post #4 rule, not a Department rule. Your 2025 card will allow you to continue to attend meetings, come to the Post (not be served any alcoholic drinks) until May 2026.

If you get notice, but already have your 2026 membership card, please ignore the notice. If in doubt, check your records, or just simply call me. These steps will keep you from paying twice and save you and me some aggravation. I am retired so I have the time to process your renew-

al as soon as I receive payment. I am not the reason you may still get renewal notices. There are benefits to paying your dues every June, one of them is the Early Bird Dinner. If you have your new card by November 8th this year you are entitled to a free dinner. That is the Sunday before Veteran's Day and of course there is no interruption in Lounge privileges.

Coming soon, your chance to make a difference at the Post. Nominations for Post #4 Officers for the year 2025-2026 will be at the General Membership meeting March 23rd. Nominations and acceptance will be at that meeting. Voting will be April 27th at the General Membership meeting starting at 7:00 P.M. We want a full ballot with some choices. A member in good standing and willing to give their best effort, is eligible to run for office. Also, a member in good standing is eligible to nominate and vote, so come and be a part of it.

Currently I have processed 754 paid members for the year 2026. We are at 83.50%, our goal is 930 memberships. 100% is in sight.

Post Constitution and By-Laws have changes or deletions there is a format that has to be done. The changes are discussed at the Executive Board meeting, the moved to the General Membership meeting if passed there a copy of the old, the new, the changes, minutes of the membership meeting. Once that is done everything is put into the VooDoo News or sent by email. Everything will be sent to the Department Adjutant which in turn sends them to the Department Judge Advocate. The membership will be notified when the changes are approved.

Post Standing Rules and Lounge Rules are done the same way as the Constitution and By-

Laws but once moved forward to the General membership meeting and a vote of the membership that are present, if passed the changes will be adopted.

Squadron 4 Constitution and By-Laws when any changes are made, will be presented to the Executive Board, if recommended to move to the membership meeting and passed they will be forwarded to the Detachment Judge Advocate for approval.

ALR Chapter 4 controls their own By-Laws as there are no National or Department By-Laws. Those By-Laws still have to be approved the General Membership.

Once everything is in place they will be on the Post Web Site under the heading "Constitution, By-Laws, Standing Rules.

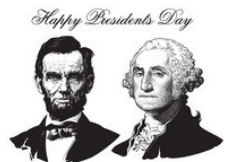
